6 WAIT TO RECEIVE YOUR REBATE.

If you currently receive your <u>personal income tax refund</u> from the Canada Revenue Agency by direct deposit, **your rebate** will be deposited into the same bank account you have registered with CRA once it's approved.

If you do not receive your income tax refund by direct deposit, your cheque will be mailed within 8-10 weeks.

Please note that it can take up to 8-10 weeks to process your paper application.
